The objective of this bid/tender is to appoint a service provider for the supply and delivery of 26 Laptops to the Limpopo Legislature and the full detailed technical specification is outlined in the bid document.

EVALUATION CRITERIA

The bid for supply and delivery of 26 Laptops to the Legislature will be evaluated on **Functionality** and Preferential points scoring system of **80/20**.

1. FUNCTIONALITY

For bidders to be evaluated further on preferential points scoring system of 80/20 a bidder must obtain at least the **minimum qualifying score of 75%** on Functionality, failure to obtain at least the minimum qualifying score, the bidder will be disqualified. Point's breakdown, requirements and how score will be allocated for functionality will be outlined in the bid document.
